## **KINGSWAY, N12** Planning applications up to Mar 2010

### **History**

5 Feb 1926. At Thursday's meeting of the MCC, the Highways Committee reported that on 29 May 1924 the County Council approved a widening scheme being carried out at Tally Ho Corner, Finchley, including the widening of the Great North Road, Ballards Lane and Nether Street and the construction of a new 60-foot roadway in continuation of Woodhouse Road connecting with Ballards Lane at a cost not exceeding £16,000 and agreed to bear a quarter of the cost. In order to facilitate the acquisition of the land required for the improvement, powers were obtained by the County Council in their General Powers Act of 1925 (*Finchley Press 5 Feb 1926. Page 1*)

To improve access to the tram depot, **Woodhouse Road** was extended to form the Kingsway in 1934, thereby pushing the whole road system further south. (*Finchley & Whetstone Past by John Heathfield. Page 93. Historical Publications 2001*)

The Kingsway was laid out in 1933 to improve access from Woodhouse Road to the tram depot in Woodberry Grove. The new road ran through the grounds of Orchard Lodge, owned by T.C. Newman, a prominent local benefactor (*The London Borough of Barnet Past & Present by Percy Reboul & John Heathfield Page 68*)
